# Call to Order:

#### Minutes:

Hershel Strickland moved to approve the minutes of June 3, 2009 as presented. Judy Trow seconded the motion. Yea – 3, Nay – 0, Abstain – 1 (Kim Denney)

## Public Forum:

Michelle Stewart and Brian and Leila Emory brought their concerns to the Board about the athletic policies in regards to partying, drinking and other lascivious behavior in the Student Athletic Handbook. They feel that wording needs to be changed for better understanding by students and their families. Also, they would like other school groups to be encompassed under the rules not just athletes as well as when the school has a right to punish a student. They do not feel that the school has the right to punish students for something that occurs over the summer; it is a parent's responsibility.

Sean Moynihan said that he and the athletic director asked students to give input for next year's student athletic handbook which will come forth to the Board in September for the first reading. The Board said they will review it then and discuss.

The Emory's also brought forth the problem of traffic on School St. in Sunapee. Cars are not supposed to be driving up on the street during certain hours or turning around in their driveway, but they are at this point. There is supposed to be a crossing guard, but there is not. The Board said they will take care of it and have a letter sent out to all parents before the school year begins next year. They will also put up a camera if need be.
